Rugby High School PTA 200 Club

The Rules of the Club. February 1994

- 1. The Club Shall be known as "The Rugby High School PTA 200 Club."
- 2. The PTA Committee member managing the Club shall be known as "the Sponsor."
- 3. Membership of the club shall be open to all adult friends of the school and to the staff of the school.
- 4. Membership shares shall cost £12 per year payable in advance by a single lump sum.
- 5. There shall be no limit to the number of shares that may be purchased by any one person.
- 6. Only fully paid up members shall be eligible for the entry to the prize draws.
- 7. Prize draws shall generally take place in the third week of each month at Rugby High School at a place and time agreed by the Parent Teacher Association.
- 8. There shall be a minimum of six adults present at prize draw meetings.
- 9. When the due date for the prize draw would fall in a school holiday, the draw shall be made at the previous draw meeting. The prizes shall not be distributed until their due date.
- 10. All monies shall be passed through a special bank account set up solely available to the Club.
- 11. A separate record of income and expenditure of the club shall be maintained by the Sponsor
- 12. 50% of monies received by the Club shall be returned to the members in prizes at monthly draws.
- 13. Each month the following prizes shall be awarded, expressed as a percentage of the month's income:
 - One prize of 20% (Equivalent to £40 with 200 members) Two prizes of 10%(Equivalent to £20 with 200 members)
- 14. Every third month one additional prize shall be drawn to the value of the balance of 50% of the previous three months' income less the three monthly prizes. (Equivalent to £60 with 200 members).
- 15. Prize cheques shall be distributed the day after the draw by post, or via school as appropriate.
- 16. All members of the Club are to be notified of the list of prize winners through a school Newsletter from time to time.
- 17. The business of the Club is to be conducted according to the regulations laid out in the Lotteries and Amusements Act 1976.
